A Behavioral Health Support program equips students with the skills and knowledge to fill this growing demand. Rationale Workforce shortages - There is a high

unmet need for behavioral health workers due to shortages, especially in rural and underserved communities. This program expands the talent pipeline. Career prospects - Jobs for substance abuse, behavioral health, and mental health technicians are projected to grow over 33% in the next decade (Bureau of Labor Statistics). This program prepares students for in-demand roles. Community needs - Local health assessments show increasing cases of mental illness, addiction, and lack of access to care in our community. This program helps build capacity to address these needs. Applied skills - With required internship hours, the program provides hands-on training unavailable through on-the-job training alone. Pathway option - The degree can serve as a career pathway for those seeking entry-level roles or as preparation for further study in social work, counseling, psychology, nursing, etc. Holistic focus - The curriculum emphasizes person-centered, compassionate, evidence-based care - the direction health services are moving. Versatility - Graduates are equipped to work across diverse settings from clinics to schools to criminal justice programs to meet individual client needs.
