5. Describe the need for this new major including evidence of student demand for the program and market or societal need for the skills being developed.

The Department of Music has historically served three different types of students: 1) students who want to teach music in the public schools, 2) students who do not want to teach music in the public schools but wish to obtain a degree in music, and 3) students who want to pursue a performance degree and/or go on to graduate school in a performance-related field. The current BS in Music Education degrees serve students in group #1 and the BA in Music degree serve students in groups #2 and #3. However, students in these two groups differ vastly from each other in terms of music ability and future goals. The demands of a performance career or future graduate studies in performance are much higher and require a much more comprehensive educational experience than what is currently offered in the BA in Music degree.

The Department of Music is currently seeking accreditation with the National Association of Schools of Music (NASM). Through this process of consultant visits, a formal visit team, and a review of self-study materials by the accrediting body, it became clear that our BA in Music degree is not serving the needs of the students of groups #2 and #3. The current requirements for the BA in Music are too strict for a liberal arts BA in Music degree while at the same time the requirements don't go far enough for a professional degree in performance. In the words of a member of the NASM visit team, "Your BA program is neither fish nor fowl. It doesn't know what it wants to be to the students." The Music faculty agreed with this assessment and it was decided to propose splitting the BA in Music degree into two, new programs that will: 1) greatly reduce the required courses in the BA in Music to fit a more liberal arts degree philosophy and 2) create a new Bachelor of Music degree with increased performance-related requirements when compared to the existing BA in Music to create a professional degree.

This proposal (along with the accompanying revamp of the BA in Music degree) will allow us to better serve these 3 distinct types of students the Department of Music has traditionally taught. It will also allow the department to better target recruiting efforts to these separate types of music students and diversify our offerings to better compete with similarly sized institutions in the region. If the department were to only reduce requirements of the current BA in Music to satisfy the accrediting body of NASM, it would alienate a significant portion of our student population and greatly diminish our recruiting opportunities.

7. Are there similar programs offered at other Missouri institutions? Yes If so, how is this program unique or different from existing programs?

Many Missouri Institutions offer a Bachelor of Music in Performance. Many of these institutions are sustainably larger than MSSU's Department of Music. These larger institutions offer graduate programs in music performance and have many more students that populate the program. These larger institutions' top groups are typically filled with graduate students and leave many undergraduates out of the possibility to participate in the highest caliber groups of the music unit. Students pursuing a BM in Performance at MSSU will have the ability to be in the top ensembles and in a less high-pressure, competitive environment. This program would not necessarily compete head-to-head with the larger programs as total music unit funding, number of full-time faculty, and larger student populations creates a vastly different learning environment than what MSSU can offer. While the degree is titled the same, and both meet the same NASM standards, students will have a choice of the type of environment in which they would like to study.

8. Describe the curriculum requirements for the major.

NASM standards dictate that degrees in performance are considered professional degrees and require at least 65% of the content of the degree (based upon 120 hour bachelor's degree) to be in music-related coursework. This proposal includes a core music area of 50% with 3 concentrations in Instrumental Performance, Vocal Performance, and Keyboard Performance of that brings the total to 66.67% music content with the remaining 33.33% in the General Education area.

The curriculum is designed to teach the entire performer with rigorous coursework in music theory, music history, individual performance, ensemble performance, pedagogy, and literature. These courses meet NASM standards for undergraduate performance degrees.

Students will be able to perform as soloists and ensemble members at appropriate levels for entry into graduate music study.

Students will be able to analyze and synthesize music in ways that helps improve performance standards.

Students will be able to recognize, classify, and interpret a common body of music literature and individual repertoire.

Students will demonstrate that public performance is a means for engaging a community of musicians and concert attendees and contribute to general cultural awareness.

The music history course sequence and literature courses will assess the common body of music literature and individual repertoire.

Ensemble and individual performances engage the community through public performance. Feedback to the performers is given after each performance. The senior recital performance will also require students to market their own performance and personally engage with the community to attend their recital.

5. Describe the need for this new major including evidence of student demand for the program and market or societal need for the skills being developed.

The Department of Music has offered a degree with Music Industry in the title for the past 7 years. Initially it was a BA in Music Industry. After pressure from the state to produce more graduates for degrees that had "low completers" this degree was moved to a concentration under the BA in Music. With the other concentrations being Instrumental Music, Keyboard Music, and Vocal Music. Most of the core requirements stayed the same as the initial version.

After a review of degrees by the National Association of Schools of Music (NASM), the prospective accrediting agency of the Department of Music, the NASM Commission on Accreditation requested that we carefully review the requirements of any degree that has Music Industry in the title. While the NASM commission noted that MSSU was not trying to offer a full-blown Music Industry degree, the commission is basically asking MSSU to change the title to something more appropriate that meets national standards for degree titles.

In order for MSSU to offer a professional music industry degree, at least 50% of the program would need to be music industry-specific classes. The current degree has 11% music industry specific content. NASM noted that the degree requires much more business classes than music industry coursework. The Department of Music does not have the depth of faculty or facilities to realistically increase the number of music industry courses. Therefore, it is required that we shift the title of the degree to something that will meet NASM standards.

The closest option that NASM approves of that fits what the Department of Music is capable of offering is a Bachelor of Music with Elective Studies in an Outside Field. NASM allows that "outside field" to be a specific field, such as business. However, leaving the outside field undefined allows us to offer this degree to a wider array of students. While the Department of Music will lose the marketing advantage of a degree with "Music Industry" in the title, it will be replaced by a Certificate in Music Industry that students completing the BM with Elective Studies in an Outside Field degree (or any other degree) can obtain.

6. Is the major interdisciplinary? Indirectly If Interdisciplinary, how will coordination between the departments be accomplished?

This degree is somewhat interdisciplinary in that it will require a specific number of hours in a field outside of music. 50% of the degree will be music-related coursework and 15% will be outside of music. The degree will require 18 hours this outside field. These 18 hours should complete a certificate or minor in another field of the student's choosing. No coordination between departments is required because there will be no coordinating coursework.

7. Are there similar programs offered at other Missouri institutions? No If so, how is this program unique or different from existing programs?

There are no state-supported institutions in Missouri that offer a BM with Elective Studies in an Outside Field. The only university that offers a comparable program is Southwest Baptist University; a private institution.

8. Describe the curriculum requirements for the major.

NASM standards dictate that degrees in performance are considered professional degrees and require at least 50% of the content of the degree (based upon 120 hour bachelor's degree) to be in music-related coursework when combined with another field. The 18 hours in an "Outside Field" should be at least 15% of the curriculum. The proposed degree meets both these standards.

The curriculum is designed to teach the entire performer with coursework in music theory, music history, individual performance, ensemble performance, pedagogy, and literature. It also allows students to seek a certificate or a minor in another field as a requirement for the degree. This degree plan meets NASM standards for undergraduate degrees titled Bachelor of Music with Elective Studies in an Outside Field.

This degree has most of the music requirements as the new BM in Performance degrees has without the heavy emphasis on individual performance. It will be suitable for students who do not see themselves as an individual performer but have the requisite music-related skills to accomplish the rest of the requirements. It should also be attractive to students who have an interest in another field of study.

5. Describe the need for this new major including evidence of student demand for the program and market or societal need for the skills being developed.

The Department of Music and the Department of Theatre have long enjoyed collaborating on a musical every other spring semester to great success. Current voice faculty are supportive of musical theatre as an important style to be studied in higher education. With this synergy and past history of a great working relationship, it is natural for the departments to formalize a degree that expresses these successful experiences.

High school vocal programs in this region are highly competitive in show choir competitions. These ensembles that feature dancing and singing have no professional groups and very few colleges and universities offer any sort of show choir ensemble. The most similar option for university-level study and professional potential is musical theatre.

The experiences of classically trained singers and actors in a musical theatre context are slightly different. These differences can be taught in new coursework while existing coursework can build a foundation in both areas. Many current students in music or theatre will be interested in this degree offering and it is believed that it will be a strong recruiting tool for both departments and the university.

- 7. Are there similar programs offered at other Missouri institutions? Yes If so, how is this program unique or different from existing programs?

There is only one NASM accredited institutions with a Bachelor of Music in Musical Theatre – American Baptist University in St. Louis. Missouri State offers a Bachelor of Fine Arts in Musical Theatre which does not offer the same type of model as this proposal that has a stronger foundation in core musicianship skills.

8. Describe the curriculum requirements for the major.

NASM standards require professional degrees in music (such as this proposal) to have around 50% music content when combined with one or more fields. This proposal contains 48% music content which should be enough to satisfy the NASM standards on the music content of the degree.

Attached is the full degree program. Courses in bold are new. The degree contains 53 hours in music, 20 hours in theatre, 10 hours in movement, and 37 hours in GE (with a music course and theatre course each using 3 hours from the GE in the respective area) for a total of 120 hours.

The curriculum is designed to teach the performer to sing, act, and dance through rigorous coursework in music, musical theatre, acting, and movement.

9. What are the student learning objectives for the program?

Students will be able to perform as soloists and ensemble members at appropriate levels.

Students will be able to analyze and synthesize music in ways that helps improve performance standards.

Students will be able to recognize, classify, and interpret a common body of music literature and individual repertoire both in classical music and musical theatre.

Students will demonstrate that public performance is a means for engaging a community of musicians and concert attendees and contribute to general cultural awareness.

Students will obtain training and skills associated with musical theatre: singing, acting, and movement/choreography.

Students will gain knowledge and understanding of the arts through rehearsals, auditions, performances, and presentations.

10. How will the objectives be assessed?

Ensemble, individual, and musical production performance standards will be assessed every semester in all performances. Solo recitals at the junior and senior levels will be capstone experiences that focus on each student's individual musicianship.

The music theory course sequence will address analyzing and synthesizing music to inform performance practices.

The music history and musical theatre course sequences and literature courses will assess the common body of music literature and individual repertoire.

Ensemble, individual, and musical production performances engage the community through public performance. Feedback to the performers is given after each performance. The senior recital performance will also require students to market their own performance and personally engage with the community to attend their recital.

A dance instructor will need to be hired to teach the dance courses if not already hired by the time the dance courses are offered.

Some library materials will need to be purchased per NASM standards. The Music Department and Theatre Departments will use some departmental allocation to increase the library's holdings of musical theatre related materials over the course of several years.

Eventually, a large performing venue will need to be available (Taylor Auditorium).

12. Include any additional information about the program that would be helpful.

MSSU would be the first and only Missouri public institution to offer a Bachelor of Music in Musical Theatre. This degree capitalizes on the good will and good working relationship of two departments and allows each to grow stronger by working on a combined degree.
