FEDERAL PELL GRANTS

An Electronic Announcement was published by the USDE March 1, 2021: First Pell Grant Administrative Cost Allowance Payments for 2020-2021 Award Year. The announcement explains which students a school is eligible to receive ACA payments for and indicates the funds may only be used to defray the costs of administering the Pell Grant, Federal Supplemental Educational Opportunity Grant, Federal Work-Study and Federal Perkins Loan programs. The USDE began processing ACA payments for all schools on Feb. 25, 2021. Contact information is provided for those schools that need assistance regarding their ACA payments.

IRS DATA RETRIEVAL TOOL

The USDE published an Electronic
Announcement March 5, 2021: IRS Data
Retrieval Tool and Inaccurate \$1 Adjusted
Gross Income. Federal Student Aid has
discovered the IRS Data Retrieval Tool is
returning an inaccurate adjusted gross
income of \$1 for individuals that used the
Internal Revenue Service's Non-Filers:
Enter Payment Info Here Tool. The error is
being investigated to determine the extent of
the problem. This announcement outlines
further details about the issue and indicates
what documents a school can use to verify
correct income and tax information or
verification of non-filing.

ANNUAL STUDENT LOAN ACKNOWLEDGEMENT

On March 8, 2021, the USDE published an Electronic Announcement: Annual Student Loan Acknowledgement – Borrower Completion Will Not be Required for 2021-2022 Award Year. Due to the continued

disruptions resulting from the coronavirus, borrowers are not required to complete the Annual Student Loan Acknowledgement for the 2021-2022 Award Year.

DISTANCE EDUCATION

Dear Colleague Letter ANN-21-04 was published March 18, 2021: Live Internet Webinars – Distance Education and Innovation Regulations – Save the Date. The USDE is hosting several webinars that explain the changes to regulatory requirements that take effect July 1, 2021. The announcement provides the dates and times of the webinars. A subsequent Dear Colleague Letter ANN-21-05 provides links to and instructions on how to register for the webinars.

RETURN TO TITLE IV

An Electronic Announcement was published by the USDE March 19, 2021: Clarification of R2T4 Guidance Related to the COVID-19 National Emergency. This announcement reminds schools of the requirement to report Title IV funds that were not returned to the USDE, due to CARES Act provisions. Examples are provided to illustrate when the R2T4 waiver applies. Instructions outline R2T4 amounts should be reported in the COD system.

SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM

The USDE published an Electronic Announcement March 19, 2021:
Designation of U.S. Department of Agriculture, Food and Nutrition Services under Section 483(a)(3)(E) of the Higher Education Act. The U.S. Department of Agriculture has been designated by the USDE as an entity allowed to use Free Application for Federal Student Aid data. The data collected will be used to determine a FAFSA applicant's eligibility for temporary SNAP benefits. Students with an EFC of zero will be contacted by the USDE regarding their eligibility by email.

PROPRIETARY SCHOOLS

On March 31, 2021, the USDE published an Electronic Announcement: Availability of Guide for Compliance Attestation
Engagements of Proprietary Schools
Expending Higher Education Emergency
Relief Fund Grants. Proprietary schools that expended \$500,000 or more total HEERF grant program funds are required to have a compliance audit conducted. Schools should ensure that their auditor uses the new Guide for Compliance Attestation Engagements of Proprietary Schools Expending Higher Education Emergency Relief Fund Grants when conducting their audit. The Guide is effective March 31, 2021. Audits should

cover the first fiscal year during which a proprietary school expended HEERF award funds.
